GENERAL PURPOSE: To set forth policies for the administration of implied consent breath alcohol tests.

POLICY: The Division will establish procedures for properly conducting implied consent BAC DataMaster breath alcohol tests.


SPECIFIC PROCEDURES: The time stamp information (depending on the software version) and instrument serial number will be printed out on the evidence ticket. The answers to test questions (2), (8) - (25), and (27) - (33) will print out on the ticket. Questions (1) and (5) - (7) are covered by the checklist on the ticket. Questions (3) and (4) are for statistical purposes only and are not printed out on the ticket. Question (26) does not print, but if a "Y" is entered and "RETURN" pressed, the answers for a second arresting officer (questions 22 - 25) will print. Question (34) mandates that the test operator review the data. The basic layout of the evidence ticket is as follows (the numbers in parentheses are the test questions from where the information was obtained):
