#### Breath Testing Program Updates – INTOX DMT Timeline

Over the next year, the SLED Implied Consent Department will be performing the changeover from the Datamaster DMT to the INTOX DMT breath testing instruments. Please be aware of the following important dates:

- Retraining and recertification will take place online through the SC Criminal Justice Academy (SCCJA) via ACADIS beginning **October 1, 2025**.
  - o Please see your agency's training officer to register and obtain this training and your new INTOX Certification number as soon as possible.
- Please refer to the attached spreadsheet to note the highlighted sites that will not be operational beginning in **October 2025**. These sites will be the first instruments replaced with new INTOX DMTs.
- The new INTOX DMTs are being put into service on **March 1, 2026**.
  - o The new INTOX DMT will not accept the old Datamaster DMT certification number.
- The remaining old Datamaster DMT instruments will not be operational after **February 28, 2026**. A continued switchover of the remaining instruments will continue into 2026 until all sites have been replaced.
