TRACK for Law Enforcement Agencies

What is Track-Kit?

Track-Kit is a web-based software for tracking sexual assault kits. It is a highly integrated solution used to track kits from distribution, to collection, to processing, to storage. Track-Kit also allows survivors to confidentially view the location and status of their kits.

Picking Up Kits

You will pick up kits from medical facilities and laboratories. You must enter mandatory fields (marked with a red asterisk *) to complete a pickup.



Entering LEA Investigation Review and Result

When the medical facility requests testing for a kit, you will receive a notification indicating that investigation results are required for the kit. You may provide investigation results at any point once the kit has been picked up from the medical facility.

1. Select the LEA Investigation Review and Result.

If you Refer the Case

- To refer the case to prosecutor, select 'Case Referred to Prosecutor'.
- Select a **Date Referred** date.

If you Decline the Case

- To decline referral to prosecutor, select 'Contact Law Enforcement Agency Assigned to Case'.
- Select a Reason for Declining Referral.
- Select an Investigation Complete date

Investigation Review and Result fields may be displayed to the survivor.

Survivor Password

You can help survivors reset their passwords.

- 1. At the bottom of the **Kit Details** page, click **Reset Survivor Password** to open the Password Reset Wizard.
- 2. Select a reset method using the radio buttons.
 - If 'Password Reset Email' or 'Password Reset Text' is selected, the account will be locked until the password has successfully been reset by the survivor.
 - If 'Manual Password Reset' is selected, you must provide the new password to the survivor so they can access the account.

TRACK for Law Enforcement Agencies

Skipping Lab Processing

You may skip lab processing for a kit in your agency's possession or at the laboratory. This feature is available once a kit is picked up from medical facility and before the kit is delivered to lab.

Skip Lab Processing

- 1. Enter/Scan the kit barcode to open the Kit Details.
- 2. Click the **Skip Lab Processing** button, then select a **Skip Lab Processing Reason**.
 - If the kit is in lab possession, a notification will be sent to the laboratory. The kit's status is not changed.
 - To reverse this action: enter or scan the kit's barcode to open **Kit Details** and click the **Undo Skip Lab Processing** button.

Transferring Kits

You can transfer kits from your agency to another law enforcement agency.

- 1. Enter/Scan the kit barcode to open the Kit Transfer Wizard.
- 2. Select the organization.
 - Commonly selected LEAs in Track-Kit appear on the **Organization** drop-down list.
 - Select **Other Organization** to open the **Organizations Lookup** table to select other LEAs, including an out-of-state.
- 3. Click Initiate Transfer.
 - If the kit is going to an LEA in Track-Kit, the transfer will stay on the **Active Transfers** worklist until the receiving LEA confirms receipt. Kits transferred out-of-state leave Track-Kit and are marked **Tracking Complete**.



Required fields missing

Kits stay on this worklist until you enter the missing data, such as the **LEA Pickup Date from MF**.
