SLED CHARGES SPARTANBURG COUNTY WOMAN WITH INSURANCE FRAUD AND FINANCIAL IDENTITY FRAUD

The South Carolina Law Enforcement Division (SLED) charged Miranda Jeanette Fuller, 47, with Presenting a False Claim for Insurance Payment – Value more than \$2,000 but less than \$10,000 and Financial Identity Fraud on Tuesday, March 24, 2026. The South Carolina Department of Insurance requested the SLED investigation.

Details can be found in the attached warrants.

Fuller was booked into the Spartanburg County Detention Center.

The case will be prosecuted by the South Carolina Department of Insurance.

DESCRIPTION OF OFFENSE: Insurance / Presenting false claim for insurance payment, value more than \$2,000 but less than \$10,000

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That on or about July 21, 2025, in the county of Spartanburg, the defendant one Miranda Fuller knowingly submitted a false claim for insurance payment to Progressive Direct Insurance Company. Fuller contacted Progressive to file an automobile claim on behalf of [REDACTED]. While doing so, Fuller falsely represented herself as the policyholder, [REDACTED] and submitted photographs depicting the vehicle damage. An investigation by Progressive determined that several of the photographs submitted by Fuller contained metadata indicating the damage pre dated the reported loss date of July 19, 2025. The investigation further revealed that the same photographs had previously been submitted from Fuller's email account to a different insurance carrier in support of an earlier claim that was denied. This Affiant presents these facts based on witness statements, electronic communication records, and electronic records.

That on or about July 12, 2025 in Spartanburg County, South Carolina, the defendant, Miranda Fuller, devised a scheme to defraud Progressive Direct Insurance Company by obtaining an automobile insurance policy through false pretenses and misrepresentations. Fuller used the personal identifying information of [REDACTED] including, but not limited to, [REDACTED] name, date of birth, and digital signature-without authorization. During a voluntarily provided audio and video recorded statement, [REDACTED] confirmed that Fuller did not have permission to use [REDACTED] personal information to obtain an automobile insurance policy with Progressive. [REDACTED] further stated that [REDACTED] was never informed of the existence of the Progressive policy. The affiant submits these facts based on [REDACTED] statements, electronic communications, and other relevant electronic records.
