HAMPTON MAN CHARGED WITH MURDER AND POSSESSION OF A WEAPON

Agents of the S.C. Law Enforcement Division charged a Hampton man Wednesday in connection to an incident from May 3 where an individual was killed.

Faizon Syheen Speed, 18, was charged with murder and possession of a weapon during the commission of a violent crime following the shooting death of Robert L Haynes, Jr.

The case was investigated by SLED at the request of the Hampton County Sheriff's Office.

Speed was booked at the Hampton County Detention Center.

The case will be prosecuted by the 14th Circuit Solicitor's Office.
