### **SUSPECT INVOLVED IN BEAUFORT COUNTY OFFICER INVOLVED SHOOTING CHARGED WITH ASSAULT AND DOMESTIC VIOLENCE**

Agents of the S.C. Law Enforcement Division arrested a man Monday in connection to a confrontation that occurred May 10 with a deputy from the Beaufort County Sheriff's Office following a domestic incident in Bluffton.

Jose Robles, 45, was charged with Assault and Battery, 1<sup>st</sup> Degree, along with Domestic Violence, 2<sup>nd</sup> Degree.

Robles is accused of attempting to strike a Beaufort County Sheriff's Deputy with a metal pipe who was there investigating a domestic violence situation. Robles was shot during the confrontation with law enforcement.

SLED's investigation into the incident remains active. Information gathered in the SLED investigation of the incident will be summarized in a case file report to be submitted to prosecutors.

This is an ongoing investigation. No other information about the case will be disclosed by SLED at this time. SLED will defer to the Beaufort County Sheriff's Office for any information about their officer.

Robles was booked Monday at the Beaufort County Detention Center.

The case will be prosecuted by the 14th Circuit Solicitor's Office.


