### **LAW ENFORCEMENT OFFICER CHARGED WITH DOMESTIC VIOLENCE**

Agents of the S.C. Law Enforcement Division on Tuesday arrested a law enforcement officer with the Richland County Sheriff's Department in connection with an assault on an individual that took place Aug. 8.

Aly H. Brun, 26, was charged with Domestic Violence, First Degree.

SLED investigated the case at the request of the Lexington Police Department.

Brun was booked at the Lexington County Detention Center.

Personally appeared before me the affiant Monty L Blackmon, Jr who being duly sworn deposes and says that defendant Aly H Brun did within this county and state on or about 8/8/2020 violate the criminal laws of the State of South Carolina (or ordinance of [X] County/ [ ] Municipality of Lexington) in the following particulars:

DESCRIPTION OF OFFENSE: Domestic / Domestic Violence, 1st degree

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On August 8, 2020, the defendant, Aly H. Brun, did commit the offense of domestic violence in the first degree against [REDACTED] and Brun formerly cohabitated and have a four-year-old child in common who was present and observed the offense. The incident occurred in the parking lot of the Lexington County Sheriff's Department, 521 Gibson Road, Lexington, S.C. during their child's custody exchange and was captured on a Lexington Police Department officer's body camera and in-car camera. Two bystanders also provided cell phone video of the incident. Brun pushed [REDACTED] and grabbed her from behind, taking her to the ground as [REDACTED] fought with Brun's current girlfriend. Brun placed his hands around [REDACTED] neck impeding [REDACTED]'s breathing. Brun threatened to kill [REDACTED] while holding her on the ground and [REDACTED] had visible injuries on her neck. The South Carolina Law Enforcement Division investigated the incident and [REDACTED] provided a statement.
