****CORRECTED** - SLED ARRESTS BAMBERG COUNTY COUNCILMAN ON SEX CRIMES**

Agents with the S.C. Law Enforcement Division yesterday arrested Bamberg County Councilman, Kerry Trent Kinard, in Bamberg on multiple violations of South Carolina law.

Kinard, 49, is charged with Criminal Sexual Conduct with a Minor 1st Degree, Attempted Criminal Sexual Contact with a Minor, two counts of Criminal Solicitation of a Minor, Assault and Battery 1st Degree and two counts of Dissemination of Obscene Material.

SLED investigated the case at the request of the Bamberg Police Department.

Kinard was booked at the Bamberg County Detention Center.

The case will be prosecuted by the Second Circuit Solicitor's Office.


