RIDGELAND MAN CHARGED WITH MURDER

A Ridgeland man was arrested by S.C. Law Enforcement Division agents today in connection with the Sept. 6, shooting death of Cypress Noonan at a motel in Ridgeland.

Brian Jemal Redding, 32, was charged with Murder, Possession of a Weapon during a Violent Crime and Possession of a Firearm by a Person Convicted of a Violent Felony.

The SLED investigation into the incident was requested by the Ridgeland Police Department.

Redding was booked at the Jasper County Detention Center.

The case will be prosecuted by the 14th Circuit Solicitor's Office.
