LAW ENFORCEMENT OFFICER CHARGED WITH MULTIPLE CRIMES

Agents of the S.C. Law Enforcement Division yesterday arrested a Captain with the Fairfax Police Department, who was in an off duty status, when during a traffic stop Agents and local law enforcement discovered the individual in possession of a stolen firearm and open container.

Donald Anthony Williams, 53, was charged with Unlawful Carrying of a Pistol, Possession of Stolen Pistol, Misconduct in Office and Open Container in Motor Vehicle.

Williams was booked at the Allendale County Detention Center.
