DESCRIPTION OF OFFENSE: Domestic / Domestic Violence, 1st degree

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On January 24, 2021 at [redacted] in the Myrtle Beach section of Horry County, one Ralph Wilson Jr., did cause physical harm or injury to his [redacted]. According to the victim's statement, the defendant hit her in the back of the head and face several times. He poured water on the victim and placed a pillow over her nose and mouth which impeded her air flow and had the substantial likelihood of causing moderate bodily or even severe bodily injury. The defendant also took the victim's cell phone and threw it into the backyard, which took away her access to call for help. This affiant observed physical injuries on the victim consistent with an altercation. All of these acts occurred in front of the defendant's [redacted] child and [redacted] child. This being in violation of Section 16-25-20, South Carolina Code of Laws.
