FLORENCE COUNTY MAN CHARGED WITH CRIMINAL CONSPIRACY

Agents of the S.C. Law Enforcement Division and members with the S.C. Department of Corrections Office of Intelligence and Investigations today arrested a Florence County man who on Dec. 27, 2020 conspired with inmates at McCormick Correctional Institute to aid in their escape.

Dallas Jeremiah Richardson Waiters, Jr., 23, was charged with Criminal Conspiracy.

SLED's participation in this investigation was requested by the S.C. Department of Corrections.

Waiters was booked at the McCormick County Detention Center.

The case will be prosecuted by the 11th Circuit Solicitor's Office.



Padgett**, who being duly sworn deposes and says the defendant, **Dallas Jeremiah Richardson Waiters**, did within this county and state on December 27, 2020, violate the criminal laws of the State of South Carolina in the following particulars:

Conspiracy / Criminal Conspiracy, Common Law

That Dallas Jeremiah Richardson Waiters did in McCormick County, South Carolina, on or about December 27, 2020, conspire with Inmate (I/M) Johnny Gregg and other inmates of the McCormick Correctional Institute (MCI), 386 Redemption Way, McCormick, SC, to aid in their escape. Waiters was communicating with I/M Gregg via his cellular phone, [REDACTED] Waiters and I/M Gregg communicated via text message discussing [REDACTED] just prior to the attempted escape. Waiters sent I/M Gregg a text message [REDACTED]
