### **FORMER LAW ENFORCEMENT OFFICER CHARGED WITH FILING FALSE STATEMENTS FOR UNEMPLOYMENT PAYMENTS**

A former deputy sheriff with the Newberry County Sheriff's Office was arrested by S.C. Law Enforcement Division agents Tuesday in connection with submitting false statements to obtain unemployment benefits while serving full time with the Sheriff's Office.

Detrick Vandice Bishop, 49, was charged with nine counts of False statements or representations, or failures to disclose material facts, to obtain or increase benefits.

The SLED investigation into the incident was requested by the Newberry County Sheriff's Office.

Bishop was booked at the Newberry County Detention Center.

The case will be prosecuted by the 8<sup>th</sup> Circuit Solicitor's Office.
