SPARTANBURG COUNTY MAN CHARGED IN VEHICLE INCIDENT THAT KILLED TEACHER

Agents of the S.C. Law Enforcement Division today arrested a man in connection with the Feb. 10 vehicle crash that killed a local teacher in Spartanburg County.

Andres Antonio Barron, 28, was charged with multiple violations. The violations include:

- Reckless Homicide
- Failure To Stop For Blue Lights Resulting In Death
- Driving Under Suspension, 1st Offense
- Failure To Return Driver's License After Notice Of Suspension
- Operating Vehicle Which Is Not Registered And Licensed
- Use Of License Plate Other Than For Vehicle Which Issued

The request for the SLED investigation was made by the 7th Circuit Solicitor's Office.

Barron was booked at the Spartanburg County Detention Center.

The case will be prosecuted by the 7th Circuit Solicitor's Office.
