### **JASPER COUNTY MAN CHARGED WITH CRIMINAL SEXUAL CONDUCT**

Agents of the S.C. Law Enforcement Division today arrested a Jasper County man for conducting sexual acts with children.

Terrance Hill, 59, was charged with three counts of first-degree criminal sexual conduct with minor under 11 years of age.

The SLED investigation was requested by the Jasper County Sheriff's Office.

Hill was booked at the Beaufort County Detention Center.

The case will be prosecuted by the 14<sup>th</sup> Circuit Solicitor's Office.

**DESCRIPTION OF OFFENSE:** Sex / Criminal sexual conduct with minor or Attempt - victim under 11 yrs of age - First degree

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That between the years of 2014-2020, the defendant, Terrance Hill, Sr., did willingly, knowingly, and unlawfully violate S.C. statute 16-3-655, Criminal Sexual Conduct with a Minor 1st Degree with [REDACTED] while inhabiting several addresses within Jasper County, SC. Between the years of 2014-2020 when the victim was 9-16 years of age, Terrance Hill, Sr. did put his fingers inside her private parts. The defendant did force the victim to have oral sex and would also perform oral sex on her. The defendant did have sexual intercourse with the victim and would ejaculate. Terrance Hill, Sr. was identified as the subject through disclosures made by the victim during a forensic interview.
