### **GREENVILLE COUNTY MAN CHARGED WITH MULTIPLE WEAPONS VIOLATIONS**

Agents of the S.C. Law Enforcement Division today arrested a man in connection with the Mar. 6 officer involved shooting incident in Greenville County where a deputy from the Greenville County Sheriff's Office fired his weapon during a confrontation with an armed individual.

Tyson Devlin Moody, 32, was charged with pointing and presenting firearms at a person, unlawful possession of a pistol, and unlawful carrying of a pistol.

Moody, who was shot during the incident and taken to the hospital with non-life threatening injuries, has since been released from the hospital. No other injuries were reported.

SLED's investigation into the incident remains active. Information gathered in the SLED investigation of the incident will be summarized in a case file report to be submitted to prosecutors.

This is an ongoing investigation. No other information about the case will be disclosed by SLED at this time. SLED will defer to the Greenville County Sheriff's Office for any information about their deputy.

Moody was booked at the Greenville County Detention Center.

The case will be prosecuted by the 13<sup>th</sup> Circuit Solicitor's Office.
