FORMER LAW ENFORCEMENT OFFICER CHARGED WITH DOMESTIC VIOLENCE

Agents of the S.C. Law Enforcement Division yesterday arrested a former deputy with the Spartanburg County Sheriff's Office in connection with a domestic incident that occurred on Dec. 23, 2020 in Spartanburg County.

Brandon Chase Johnson, 26, was charged with third-degree domestic violence.

The request for the SLED investigation was made by the Spartanburg County Sheriff's Office.

Johnson was booked at the Spartanburg County Detention Center.

The case will be prosecuted by the S.C. Attorney General's Office.
