DESCRIPTION OF OFFENSE: Arson / Arson - Second degree

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That on April 29, 2021, in the County of Horry, one Terry Franklin Brady, did willfully and maliciously set fire to, burn, or cause to be burned a dwelling located at 140 Miles Standish Court in Conway, S.C. Prior to the fire, Brady was involved in a vehicle pursuit and shooting with Horry County Police Officers. Brady wrecked his vehicle and entered the dwelling at 140 Miles Standish Court, where he was admittedly the only person there at the time. Brady exited the residence and barricaded himself in a vehicle in the yard. While officers were attempting to apprehend Brady, they observed smoke extending from the dwelling. The South Carolina Law Enforcement Division Arson Investigations Unit conducted an examination of the scene and were able to determine the fire was intentionally set (Arson) using open flame and available combustible materials.
