### **AIKEN COUNTY MAN CHARGED WITH VOYEURISM**

Agents of the South Carolina Law Enforcement Division Wednesday arrested an Aiken County man in connection to an incident where he is accused of secretly video recording another person without their consent while the individual was in the bedroom of a rental house.

Rhett Riviere, 67, was charged with voyeurism.

The SLED investigation was requested by the Aiken Department of Public Safety.

Riviere was booked at the Aiken County Detention Center.

The case will be prosecuted by the 2<sup>nd</sup> Circuit Solicitor's Office.
