FORMER LAW ENFORCEMENT OFFICER CHARGED WITH MULTIPLE COUNTS OF CRIMINAL SEXUAL CONDUCT

Agents of the South Carolina Law Enforcement Division Monday arrested a former law enforcement officer with the Moncks Corner Police Department for having sex with a student at Berkeley High School while working as the School Resource Officer (SRO).

Zedrick Maurice Smalls, 50, was charged with four counts of second degree criminal sexual conduct with minor, along with one count of third degree criminal sexual conduct with minor.

The request for the SLED investigation was made by the Moncks Corner Police Department.

Smalls was booked at the Berkeley County Detention Center.

The case will be prosecuted by the 9th Circuit Solicitor's Office.


