BAMBERG COUNTY MAN CHARGED WITH MURDER

Agents of the South Carolina Law Enforcement Division Monday charged a Bamberg County man in the shooting death of Shakeira Waymyers and the attempted killing of another individual during a shooting incident July 5 in Denmark.

Kelcie Ralph Gilbert, 31, was charged with murder and attempted murder.

The SLED investigation was requested by the Denmark Police Department.

Gilbert is booked at the Bamberg County Detention Center.

The case will be prosecuted by the 2nd Circuit Solicitor's Office.
