FORMER DETENTION CENTER OFFICER CHARGED WITH ASSAULT AND BATTERY, MISCONDUCT IN OFFICE

Agents of the S.C. Law Enforcement Division Wednesday arrested a former Detention Center Officer with the Darlington County Sheriff's Office in connection with a June 2 use of force incident at the W. Glenn Campbell Detention Center.

Lejean Detrail Davis, 44, was charged with third degree assault and battery along with misconduct in office.

SLED investigated the case at the request of the Darlington County Sheriff's Office.

Davis was booked at the W. Glenn Campbell Detention Center.

The case will be prosecuted by the 4th Circuit Solicitor's Office.

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On June 2, 2021, Lejean Davis, willfully and unlawfully failed to properly and faithfully discharge the lawful duties as a sworn Detention Officer with the Darlington County Sheriff's Office W. Glenn Campbell Detention Center (WGDC). Davis displayed an unreasonable and unjustified use of force within the WGDC when she tased the victim, WGDC Inmate while he was handcuffed, and showing no threat to Davis or other staff. These facts are supported by video evidence and statements provided by the victim and witnesses. Knowing these facts, Lejean Davis did commit the offense of Misconduct in Office, Common Law.
