FORMER DETENTION OFFICER CHARGED WITH FURNISHING CONTRABAND, MISCONDUCT IN OFFICE

Agents of the S.C. Law Enforcement Division Wednesday arrested a former Detention Officer for repeatedly providing a cellphone to an inmate at the Darlington County Prison Camp. He also is accused of accepting monies from inmates and from family members of inmates at the facility.

Ron Stephone Miller, 31, was charged with furnishing contraband to an inmate, along with misconduct in office.

SLED investigated the case at the request of the S.C. Department of Corrections.

Miller was booked at the W. Glenn Campbell Detention Center.

The case will be prosecuted by the 4th Circuit Solicitor's Office.

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:
Between March of 2020 to December of 2020, Lieutenant (Lt.) Ron Miller, willfully and unlawfully failed to properly and faithfully discharge the lawful duties as a sworn Detention Officer with Darlington County Prison Camp (DCPC). While employed at the DCPC, 200 Camp Road, Darlington, South Carolina, Darlington County, Lt. Ron Miller, committed the criminal offense of Misconduct in Office. Lt. Miller obtained monies physically and via Cash App from inmates and from the family members of inmates housed at the DCPC. Lt. Miller also knowingly allowed and assisted with inmates possessing cell phones as well as contraband. These facts are supported by a witness and Lt. Miller's confession during a Mirandized interview.
