FORMER DETENTION CENTER OFFICER CHARGED WITH MISCONDUCT IN OFFICE

Agents of the S.C. Law Enforcement Division Thursday arrested a former Detention Center Officer for providing funds to and engaging in an inappropriate relationship with an inmate at the W. Glenn Campbell Detention Center.

Jessica Graham, 30, was charged with misconduct in office.

SLED investigated the case at the request of the Darlington County Sheriff's Office.

Graham was booked at the W. Glenn Campbell Detention Center.

The case will be prosecuted by the 4th Circuit Solicitor's Office.

in the following particulars:

DESCRIPTION OF OFFENSE: Miscconduct / Miscconduct in office, malfeasance, misfeasance, or nonfeasance

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

Jessica Graham did in Darlington County, between the dates of April 2021 through June 2021, and while employed by Darlington County as a sworn correctional officer, willfully, dishonestly, and unlawfully fail to discharge the lawful duties imposed upon her by law: to wit: Jessica Graham committed acts of misconduct by engaging in an inappropriate relationship with an incarcerated female inmate at the W. Glenn Campbell Detention Center. Jessica Graham also provided funds to the female inmate's commissary account. The above information was corroborated and supported by legally obtained recorded detention center telephonic conversations between Jessica Graham and the female inmate, and digital records of the female inmate's commissary account. Based on these facts, Jessica Graham did commit the offence of Miscconduct in Office by acts contrary to her sworn duties. This was done in violation of the Common Law of South Carolina. All against the law, peace, and dignity of the State of South Carolina.
