FORMER LAW ENFORCEMENT OFFICER CHARGED WITH INDECENT EXPOSURE AND OTHER CRIMES

Agents of the South Carolina Law Enforcement Division Friday arrested a former deputy with the Cherokee County Sheriff's Office in connection with an incident where he exposed his private parts and touched an individual without their consent.

Shelby Todd Singleton, 46, was charged with indecent exposure, second degree assault and battery, along with misconduct in office.

The request for the SLED investigation was made by the Cherokee County Sheriff's Office.

Singleton was booked at the Cherokee County Detention Center.

The case will be prosecuted by the South Carolina Attorney General's Office
