GREENVILLE COUNTY WOMAN CHARGED WITH INTIMIDATION AND THREATENING LIFE OF PUBLIC OFFICIAL

Agents of the South Carolina Law Enforcement Division Friday charged a Greenville County woman for threatening to shoot a 13th Judicial Circuit employee and harm the employee's family.

Reva Louise Shealy, 64, was charged with threatening life of a public official, along with intimidation of court officials, jurors or witnesses.

The SLED investigation was requested by the 13th Circuit Solicitor's Office.

Shealy was booked at the Greenville County Detention Center.

The case will be prosecuted by the 13th Circuit Solicitor's Office.

During multiple recorded phone calls with Greenville County Detention Center Inmate Rockford Lewis, who was awaiting trial for Murder: Reva Shealy, Lewis' mother, did threaten to destroy, impede, or attempt to obstruct or impede the administration of justice by threatening to shoot Thirteenth Judicial Circuit [redacted] lived; and discussed attempts to identify [redacted] to prosecute Lewis, then kill herself, she would find out where [redacted] and family members. Phone calls were identified as having taken place between January 1, 2020, through August 5, 2021.
