### **CLARENDON COUNTY MAN CHARGED WITH HOMICIDE BY CHILD ABUSE**

Agents of the South Carolina Law Enforcement Division arrested a Clarendon County man on Monday for the November 16, 2021, death of a 3-month-old child.

Ny’Jshore Jareek Green, 20, was charged with Homicide by Child Abuse.

The request for the SLED investigation was made by the Clarendon County Sheriff’s Office.

Green was booked at the Clarendon County Detention Center.

The case will be prosecuted by the 3<sup>rd</sup> Circuit Solicitor’s Office.

being duly sworn deposes and says that defendant Ny'Jshore Jareek Green   
did within this county and state on or about 11/16/2021 violate the criminal laws of the   
State of South Carolina (or ordinance of  County/  Municipality of Clarendon )   
in the following particulars:

DESCRIPTION OF OFFENSE: Murder / Homicide by child abuse (20Y to Life)

I further state that there is probable cause to believe that the defendant named above did commit   
the crime set forth and that probable cause is based on the following facts:

On November 16, 2021, the defendant Ny'jshore Green did commit the crime of Homicide By Child Abuse at   
Manning SC. Deputies responded to the above location in reference to three-month-old who was unresponsive   
and cold to touch. The defendant was caring for him that day. He was rushed to the hospital   
by EMS where he was pronounced deceased. An autopsy revealed a large skull fracture due to blunt force trauma on the right side of   
head. The defendant caused the injuries resulting in death, and the injuries occurred under circumstances   
manifesting in an extreme indifference to human life.
