Personally appeared before me the affiant Kevin N Blake who being duly sworn deposes and says that defendant Jaczuile Dominique Pegues did within this county and state on or about 3/11/2021 violate the criminal laws of the State of South Carolina (or ordinance of  County/  Municipality of Kershaw) in the following particulars:

DESCRIPTION OF OFFENSE: Misconduct / Misconduct in office, malfeasance, misfeasance, or nonfeasance

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On or about March 11, 2021, the defendant, a former Camden Police Department Officer did assist his girlfriend, Tierney Peterson, in avoiding law enforcement after he learned Peterson was involved in a burglary that occurred at \_\_\_\_\_ Lugoff, SC. The def had knowledge Peterson was at least a witness to a crime and may have had information regarding the alleged crime and did not inform law enforcement of her whereabouts. Between March 13-25, 2021, while Peterson was incarcerated in the Kershaw County Detention Center the def did provide information to Peterson regarding other inmates that the inmates would not have had otherwise. Between March 13-25, 2021 the def had approximately 62 phone calls while on duty and off duty with Peterson while she was incarcerated. The def's communication with Peterson violated CPD General Order 1.24, which barred CPD personnel from knowingly associating with persons engaged in criminal activity. The above is substantiated by recorded jail calls and def statements
