FORMER DARLINGTON COUNTY DETENTION CENTER OFFICER CHARGED WITH MISCONDUCT IN OFFICE AND POSSESSION OF MARIJUANA

Agents from the South Carolina Law Enforcement Division arrested Devonte Rashawn Harrell on Monday for Misconduct in Office and Possession of Marijuana. The subject was formerly employed as a correctional officer with the W. Glenn Campbell Detention Center.

The request for the SLED investigation was made by the Darlington County Sheriff's Office.

Harrell was booked into the W. Glenn Campbell Detention Center on Monday, January 31, 2022.

The case will be prosecuted by the 4th Circuit Solicitor's Office.
