PICKENS COUNTY WOMAN ARRESTED FOR HINDERING

On January 30, 2022, a deputy from the Oconee County Sheriff's Office was shot at during a traffic stop and subsequent foot pursuit. Subsequently, the Oconee County Sheriff's Office charged Zachary Edwin Fiskeaux with attempted murder, possession of a firearm during the commission of a violent crime, possession of a firearm by a violent felon, failure to stop for blue lights as well 4 traffic offenses.

SLED agents were requested to assist in locating Fiskeaux by the Oconee County Sheriff's Office. On February 1, 2022, SLED agents arrested Fiskeaux in Pickens County on the outstanding warrants. Jessica Morris was also arrested by SLED for hindering/interfering for harboring Fiskeaux. Fiskeaux was booked into the Oconee County Detention Center by the Oconee County Sheriff's Office. Morris was booked into the Pickens County Detention Center by the Pickens County Sheriff's Office and SLED.
