I further state that there is probable cause to believe that the defendant named above did commit
the crime set forth and that probable cause is based on the following facts:

That on or about February 10, 2022, the defendant, Joseph Tommy Loadholt, did unlawfully possess body armor stolen during a
burglary. Loadholt did admit to the burglary and taking the items. The body armor was recovered from Loadholt's residence. He did
admit to possessing the body armor and led law enforcement to its hidden location. Loadholt has been convicted of a violent crime,
