On Thursday, SLED agents arrested Glenn Hibbard, 41, for Unlawful Communication and Threatening the Life, Person or Family of a Public Official.

SLED was requested to investigate by the Union County Sheriff's Office.

Hibbard was booked at the Union County Detention Center.

Because this case involves a law enforcement official in Union County, the 16th Circuit Solicitor's Office referred this case to be prosecuted by the 7th Circuit Solicitor's Office.
