**SLED ARRESTS COLLETON COUNTY FATHER AND THREE SONS FOR
SHOOTING AT, INJURING PASSENGERS IN TRUCK**

On Thursday, agents with the South Carolina Law Enforcement Division (SLED) arrested Melvin Lemacks, 56, and his sons Louis, 25, Zakery, 19, and Ellison, 17, for 5 counts each of Attempted Murder and 1 count each of Possession of a Firearm during Commission of a Violent Crime.

Details of the incident are included in the attached warrants and affidavits.

SLED was requested to assist by the Colleton County Sheriff's Office.

Subjects were booked at the Colleton County Detention Center.

This case will be tried by the 14th Circuit Solicitor's Office.

Johnson of SLED who first being duly sworn, deposes and says that, **Ellison Lemacks (white male, DOB [REDACTED] 2005)** did within this county and state on or about April 1, 2022 violate the criminal laws of the State of South Carolina in the following particulars:

DESCRIPTION OF OFFENSE

Possession of a Firearm during Commission of a Violent Crime 16-23-490

The affiant states there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based upon the following facts:


That on April 1, 2022 the defendant Ellison Lemacks; did willingly, knowingly, and feloniously violate S.C. statute of *Possession of a Firearm during Commission of a Violent Crime 16-23-490* with malice aforethought, while in the area of [REDACTED] in the town of Walterboro, within the County of Colleton, SC in the following particulars:

On April 1, 2022 the defendant and his co-defendants stopped the victim's vehicle in the roadway on Logan Farm Road near the defendant's driveway entrance and struck the victims vehicle with a baseball bat. The defendant and his co-defendants opened fire on the victim's vehicle on Logan Farm Road striking the vehicle numerous times, subsequently disabling it. The victim's vehicle, which was occupied by five individuals, four of which were struck by gunfire. The victims fled their vehicle on foot and were stopped by law enforcement a short distance away and treated them for a multitude of gunshot wounds of different calibers. The victims were transported to area hospitals and survived their injuries. The defendant and co-defendants identified themselves as the individuals who fired at the victim's vehicle with several different styles of firearms.

The above facts are believable based on the experience, knowledge and investigation conducted jointly by the South Carolina Law Enforcement Division and Colleton County Sheriff's Office.
