SLED CHARGED CHESTERFIELD COUNTY WOMAN WITH FINANCIAL EXPLOITATION OF A VULNERABLE ADULT, BREACH OF TRUST

Agents from the South Carolina Law Enforcement Division (SLED) arrested Sherika King, 38, on Wednesday night and charged her with two counts of Financial Exploitation of a Vulnerable Adult and one count of Breach of Trust with Fraudulent Intent. Details can be found in the warrants attached.

SLED's Vulnerable Adults Investigations Unit was requested on December 10, 2021 by Chesterfield County Sheriff James Dixon.

King was booked at the Chesterfield County Detention Center.

The case will be prosecuted by the 4th Circuit Solicitor's Office.
