SLED CHARGES CALIFORNIA MAN WITH MURDER, BURGLARY, ARMED ROBBERY AND POSSESSION OF A WEAPON DURING A VIOLENT CRIME

Today agents from the South Carolina Law Enforcement Division (SLED) charged Kentavious Tyrek Harris, 28, with Murder, Burglary 1st Degree, Armed Robbery and Possession of a Weapon During a Violent Crime. Details from the investigation are in the attached warrants.

SLED was requested to investigate by the Calhoun Falls Police Department.

Harris was booked at the Abbeville County Detention Center today.

The case will be prosecuted by the 8th Circuit Solicitor's Office.
