SLED CHARGES YORK COUNTY MAN WITH SEXUAL ASSAULT

On Tuesday, agents from the South Carolina Law Enforcement Division (SLED) charged Timothy Charles Andrew McCog, 20, of Clover, SC with Sexual Assault with Intent to Commit Criminal Sexual Conduct with a minor.

Details of the investigation are in the warrant attached.

SLED was requested to investigate by the Lancaster County Sheriff's Office.

McCog was at the Cherokee County Detention Center for unrelated charges. He was transported to and booked at the Lancaster County Detention Center.

The case will be prosecuted by the 6th Circuit Solicitor's Office.
