Riddle was booked at the Allendale County Detention Center.

DESCRIPTION OF OFFENSE: Assault / Attempted Murder

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That on June 1, 2022, in the county of Allendale, one Savion Jabbar Riddle did commit the crime of Assault / Attempted Murder in the following particulars: on June 1, 2022, Riddle was identified by a witness to be brandishing a firearm at approximately 6pm while standing outside a mobile home located in Patterson Trailer Park which is located across the street from Allendale Manor Apts. As the witness drove by Riddle's location, Riddle waved a black in color firearm in the direction of the witness. The witness then heard approximately 6-7 gunshots and car was struck by gunfire as exited the trailer park and turned onto Main St. The victim was inside apartment at when was shot in the head when a bullet entered apartment thru a window was airlifted for treatment. Bullet fragments were recovered from the apartment complex, witness vehicle, and an adjacent business.
