Agents from the South Carolina Law Enforcement Division (SLED) arrested Keith Sharpe, 21, of Aiken, SC, on Wednesday and charged him with four counts of Attempted Murder.

Sharpe was booked at the Bamberg County Detention Center.

The case will be prosecuted by the Second Circuit Solicitor's Office.


