### **SLED CHARGES WILLIAMSBURG COUNTY MAN WITH MULTIPLE DRUG OFFENSES**

On Thursday, agents from the South Carolina Law Enforcement Division (SLED) arrested Teridal Deshon Burgess, 43, of Kingtree, S.C. for:

- Failure to secure a required beer or wine sale permit
- Possession with intent to distribute drugs near a school
- Possession of cocaine, 1<sup>st</sup> offense

Details from the investigation are in the attached warrants.

SLED's Alcohol Enforcement Unit was requested by the Kingtree Police Department.

Burgess was booked at the Williamsburg County Detention Center.

The case will be prosecuted by the 3<sup>rd</sup> Circuit Solicitor's Office.
