Personally appeared before me the affiant Tyrell D Praileau who being duly sworn deposes and says that defendant Richard Ray Bailey, Jr did within this county and state on or about 8/3/2022 violate the criminal laws of the State of South Carolina (or ordinance of County/ Municipality of Kershaw) in the following particulars:

DESCRIPTION OF OFFENSE: Sex / Voyeurism, violating place of privacy, views, photographs, records or films, 1st offense

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On August 3, 2022, [REDACTED] reported to the Kershaw County Sheriff's Office (KCSO) that an incident occurred at [REDACTED] Cassatt, SC, involving [REDACTED] and [REDACTED] Richard Bailey on July 28, 2022. [REDACTED] stated that on Friday, July 29, 2022, [REDACTED] set phone up in the living room of [REDACTED] and pointed the camera toward the bathroom door with the phone set to record. The phone captured Richard walking back and forth to the bathroom door while [REDACTED] was in the shower. The affiant reviewed the phone video which depicted Richard placing his cell phone under the door several times to capture either videos or photos of [REDACTED] while [REDACTED] was in a state of undress. [REDACTED] stated that after viewing the video on [REDACTED]'s phone, [REDACTED] confronted Richard who advised he was attempting the capture [REDACTED] having phone conversations with friends.
