Agents with the South Carolina Law Enforcement Division (SLED) arrested Larry Kadeem Green, 29, of Florence, SC, on December 1, 2022, for Furnishing or Possessing Contraband and Misconduct in Office.

Personally appeared before me the affiant Eric J Johnson who being duly sworn deposes and says that defendant Larry Kadeem Green did within this county and state on or about 10/8/2022 violate the criminal laws of the State of South Carolina (or ordinance of [X] County/ [] Municipality of Darlington) in the following particulars:

DESCRIPTION OF OFFENSE: Prisoners / Contraband, furnish. or poss., county or municipal prisons prohibited

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On or about October 8, 2022, Larry Kadeem Green did in Darlington Co., commit the offense of Furnishing or Possessing Contraband, to wit: while acting in his official capacity as a correctional officer for the Darlington Co. Prison Camp, Green received contraband from an inmate at the prison camp. Green removed the contraband from the prison camp, but later reintroduced the contraband and returned the contraband to the inmate the following day. The Affiant's belief is based upon statements obtained during the investigation, video surveillance evidence, and a post-Miranda Rights admission by Green that prove the same. This was done in violation of the SC Code of Laws 24-07-0155.

AFFIDAVIT Personally appeared before me the affiant Eric J Johnson who being duly sworn deposes and says that defendant Larry Kadeem Green did within this county and state on or about 10/ 8/2022 violate the criminal laws of the State of South Carolina (or ordinance of [X] County/ [] Municipality of Darlington) in the following particulars:

DESCRIPTION OF OFFENSE: Misconduct / Misconduct in office, malfeasance, misfeasance, or nonfeasance

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On or about October 8, 2022, Larry Kadeem Green did in Darlington Co., violate the Common Law offense of Misconduct in Office, to wit: while acting in his official capacity as a correctional officer for the Darlington Co. Prison Camp, Green committed malfeasance, misfeasance, and nonfeasance by deceitfully and unlawfully receiving contraband from an inmate at the prison camp. Green intentionally failed to properly seize, report, and document the contraband; instead, Green returned the contraband to the inmate. The Affiant's belief is based upon statements obtained during the investigation, video surveillance evidence, and a post-Miranda Rights admission by Green that prove the same. This act is contrary to Green's official duties and in violation of the Common Law of South Carolina.
