SLED CHARGES SUBJECT IN WILLIAMSBURG COUNTY **OFFICER INVOLVED SHOOTING**

Agents with the South Carolina Law Enforcement Division (SLED) charged Darrell Lee Williams, Jr., 37, of Lake City, SC, on Thursday, December 1, 2022 with:

- 7 counts of Assault & Battery - 1st degree
- Possession of a Firearm by a Person Convicted of a Violent Felony
- Use of a Firearm while Under the Influence of Alcohol or Drugs

Details from SLED's investigation can be found in the attached warrants.

SLED was requested to investigate the Officer Involved Shooting (OIS) by the Williamsburg County Sheriff's Office on November 17, 2022. SLED's OIS investigation remains active and ongoing.

The case will be prosecuted by the 3rd Circuit Solicitor's Office.
