### **SLED CHARGES 2 FORMER DARLINGTON COUNTY CORRECTIONAL OFFICERS WITH MISCONDUCT IN OFFICE AND POSSESSION OF MARIJUANA**

Agents with the South Carolina Law Enforcement Division (SLED) charged Eunisha Marie Campbell, 21, and Jade Symone Scarborough, 27, with Misconduct in Office and Possession of Marijuana – 1<sup>st</sup> offense.

SLED was requested to investigate by the Darlington County Sheriff's Office. Details can be found in the attached warrants.

Campbell and Scarborough were booked at the W. Glenn Campbell Detention Center.

The case will be prosecuted by the 4<sup>th</sup> Circuit Solicitor's Office.
