Agents with the South Carolina Law Enforcement Division (SLED) charged Carrol Moore Hall, 58, of West Columbia, SC, on January 4, 2023, with Abuse of a Vulnerable Adult. The victim is a resident of the Midlands Regional Center, which is under the South Carolina Department of Disabilities and Special Needs (SCDDSN).

That on or about DECEMBER 9, 2022 while at 8301 FARROW RD (MIDLANDS REGIONAL CENTER) in the UPPER TOWNSHIP Magisterial District of Richland County it is believed that one CARROL MOORE HALL did commit the crime of ABUSE OF VULNERABLE ADULT in that while working as a Direct Support Professional, at Midland Regional Center she did place the victim, [Redacted] in a chokehold three times and took [Redacted] down to the floor twice. The victim is a resident of Midlands Regional Center and is a vulnerable adult. These allegations were corroborated through interviews, surveillance videos and information provided to the South Carolina Law Enforcement Division. Incident was captured on video.
