### **SLED CHARGES SUBJECT IN CONWAY OFFICER INVOLVED SHOOTING**

Agents with the South Carolina Law Enforcement Division (SLED) charged Tywrell Jakob Alston, 18, of Conway, SC, on January 13, 2023, for his involvement in an Officer Involved shooting that occurred on December 29, 2022 in Conway, SC.

Alston was charged with:

- Attempted Murder
- Possession of a Weapon during a Violent Crime
- Possession of a Firearm by a Person Convicted of a Violent Felony
- Pointing and Presenting a Firearm at a Person
- Use of a Firearm while Under the Influence of Alcohol or Drugs
- Discharging a Firearm into a Dwelling
- Discharging a Firearm into a Vehicle

Details can be found in the attached warrants.

Alston was booked at the J. Reuben Long Detention Center.

The case will be prosecuted by the 15<sup>th</sup> Circuit Solicitor's Office.
