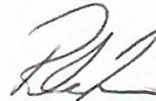

Turner who being duly sworn deposes and says that defendant Sherry Rodgers Kirkland did within this county and state on or about January 1, 2018, violate the criminal laws of the State of South Carolina in the following particulars: Breach of Trust (More than \$10,000)

I further state that there is probable cause to believe the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

Sherry Rodgers Kirkland did knowingly, willingly, and without the lawful authority to do so, take, steal, or convert to her ownership, more than \$10,000.00 from her employer, the Amick Grove Pentecostal Holliness Church, where she held a position of trust. This offense occurred between January 1, 2011, and December 12, 2018 at 2090 Batesburg Highway, Batesburg, SC, which is located within the legally recognized boundaries of Saluda County, South Carolina.

This being in violation of 16-13-230 (A) (B) (3) of the South Carolina Code of Laws as ammended.
