### **SLED ARRESTS MAN FOR ARMED ROBBERY IN HORRY COUNTY BANK ROBBERY**

Agents with the South Carolina Law Enforcement Division (SLED) charged John Henry Stack, Jr., 75, of Myrtle Beach, SC, with Armed Robbery and Entering a Bank with the Intent to Steal.

SLED was requested by Aynor Police Department to investigate a bank robbery that happened Friday, March 10, 2023 at an Anderson Brothers Bank within the city limits of Aynor, SC.

Details are in the warrants attached.

Stack was booked at The J. Reuben Long Detention Center.

The case will be prosecuted by the 15<sup>th</sup> Circuit Solicitor's Office.

After receiving the money, Stack Jr. left the bank, and fled in a white Ford Focus. Stack Jr. was arrested in Myrtle Beach and consented to a video recorded post-Miranda interview. During the interview, Stack Jr. admitted to the robbery, and provided intimate details of the offense. Knowing these facts, there is sufficient evidence to believe Stack Jr. violated 16-11-330(A), South Carolina Code of Laws.
