SLED INVESTIGATING OFFICER INVOLVED SHOOTING **IN DILLON COUNTY**

Agents from the South Carolina Law Enforcement Division (SLED) are investigating an officer involved shooting that occurred on Tuesday, March 21, 2023, in Dillon County.

On Tuesday evening, deputies from the Dillon County Sheriff's Office and the Robeson County Sheriff's Office in North Carolina responded to a home near Lake View, SC in search of an individual believed to be involved in a North Carolina drive-by shooting. As deputies approached the residence, there was an exchange of gunfire between an armed male subject, later identified as Jessie Armando Aceves, 31, and the deputies. Deputies retreated from the property and called SLED. The SLED SWAT Team, SLED's Aviation Unit, SLED's Crime Scene Unit and SLED Region Agents responded to the scene. Aceves was apprehended shortly after midnight on Wednesday, March 22, 2023. No one was injured.

Aceves was charged with 3 counts of Attempted Murder, Possession of a Firearm During the Commission of a Violent Crime, Unlawful Possession of a Handgun, Pointing and Presenting a Firearm, Discharge of a Firearm into a Vehicle. The 4th Circuit Solicitor's Office will prosecute the case.

This officer involved shooting is an ongoing investigation. As such, no other information about the case will be disclosed by SLED at this time.

SLED conducts law enforcement officer involved shooting (OIS) investigations at the request of the agency involved in the incident or the agency with jurisdiction. When requested to investigate an OIS, SLED's goal is to conduct a thorough, independent criminal investigation as timely as is possible under the circumstances. SLED agents will conduct interviews with all potential witnesses in this matter. Further, SLED will collect all relevant evidence and will forensically test such evidence as needed. Information gathered in the SLED investigation of the incident will be summarized in a case file report to be submitted to prosecutors.

The incident in Dillon County was the 8th officer involved shooting in South Carolina in 2023. This is the 1st officer involved shooting by the Dillon County Sheriff's Office this year.

In 2022, there were 32 officer involved shootings in South Carolina. The Dillon County Sheriff's Office had no officer involved shootings last year.



On March 21, 2023, [REDACTED] (DCSO) [REDACTED] Robeson County [North Carolina] Sheriff's Office (RCSO) [REDACTED] and RCSO [REDACTED] approached the residence at [REDACTED] Hayestown Road, Dillon County, in reference to a homicide that occurred earlier in the day in Robeson County, NC. Jessie Aceves was on the front porch of the residence and presented a handgun. Aceves discharged his handgun multiple times in the direction of the deputies, striking the RCSO vehicle twice, while occupied. Law enforcement returned fire, as they retreated. Aceves and a Taurus 9mm handgun (ADE311723) were later located by law enforcement in an abandoned house behind Aceves' residence. These facts are supported by witness statements, the post-Miranda interview of Aceves, and physical evidence collected during the investigation. Aceves' criminal history indicates he received a conviction for Robbery (2011) and is currently a fugitive from justice from the state of Texas for a Parole violation (Assault on Family Member - more than twice in 12 months). With these facts, the Defendant did commit the offense of Unlawful Possession of a Handgun, a violation of SC code of laws 16-23-30.
