### **SLED CHARGES GREENVILLE COUNTY MAN WITH HUMAN TRAFFICKING AND VOYEURISM**

Agents with the South Carolina Law Enforcement Division (SLED) charged Justin Stoddard, 35, of Piedmont, SC, on April 14, 2023, with:

- 4 counts of Trafficking in Persons with the Victim under 18 years old – 1<sup>st</sup> Offense
- 4 counts of Voyeurism

Details can be found in the attached warrants.

On March 16, 2023, Stoddard was previously arrested and booked into the Greenville County Detention Center on nine (9) attached warrants, which included:

- 4 counts of Criminal Sexual Conduct with a Minor in the Second Degree
- 4 counts of Sexual Exploitation of a Minor – First Degree
- 1 count of Obscene/Disseminating Obscene Material to a Minor 12 years old or younger

The case will be prosecuted by the 13<sup>th</sup> Circuit Solicitor's Office.
