SLED CHARGES GREENVILLE COUNTY WOMAN WITH MULTIPLE OFFENSES IN TWO COUNTIES

On January 23, 2020, the South Carolina Law Enforcement Division (SLED) received a request for assistance from the Duncan Police Department (DPD) in reference to a fraud investigation located within the Town of Duncan involving a former Game Day BBQ employee, Angela Byars, 50, of Greer, SC. DPD requested SLED to investigate because crimes potentially occurred in multiple jurisdictions. During the ensuing SLED investigation, it was determined Angela Byars committed multiple criminal offenses in Spartanburg and Greenville Counties.

On August 24, 2022, Angela Byars was arrested for three counts of Forgery value less than \$10,000 and one count of Financial Transaction Card Fraud value \$500 or less in a six-month period for crimes she committed in Greenville County, SC. Byars was unable to make bond on the charges in Greenville County and remained at the Greenville County Detention Center until March 20, 2023. Byars later pled guilty.

On December 1, 2022, a SLED Narcotics Agent served an arrest warrant on Byars for Possession with Intent to Distribute Methamphetamine. The drug charge resulted from methamphetamine located at Byars' residence during the fraud investigation.

On March 13, 2023, Byars pled guilty in Greenville County to Forgery value less than \$10,000.00, Financial Transaction Card Fraud value \$500 or less in a six-month period, and Possession of less than one gram of Methamphetamine.

On March 20, 2023, Angela Byars was released from GCDC into SLED's custody. Byars was transported to the Spartanburg County Detention Center (SCDC) on the following six charges: Three counts of Financial Transaction Card (FTC) Fraud value more than \$500 in a six-month period, two counts of Forgery value less than \$10,000, and one count of Forgery no dollar amount. Byars bonded out of Spartanburg County Detention Center on March 23, 2023.

The offenses that occurred in Greenville County were prosecuted by the 13th Circuit Solicitor's Office. The offenses that occurred in Spartanburg County will be prosecuted by the 7th Circuit Solicitor's Office.
